### **Student's Right-to-Know Disclosure Completion Rates**

The Student Right-to-Know Act requires an institution that participates in any student financial assistance program under Title IV of the Higher Education Act of 1965 (as amended) to disclose information about graduation rates to current and prospective students.

The National Center for Education Statistics, through the Integrated Post-Secondary Education Data System (IPEDS), developed the graduation rate component to help institutions satisfy the requirements of the Student Right-to-Know legislation. This graduation rate component includes the cohort of full-time, first-time degree/certificate-seeking undergraduate students and tracks their completion status at 150% of the normal time to complete all the requirements of their program of study. The required cohort has been defined through IPEDS. The 2018 cohort is required to be disclosed for the 2022-2023 federal student aid award year.

The **2018 Cohort Completion Rate** for first-time students in full-time programs at Fortis College – Indianapolis is **44%**. This rate is based on the 91 students who started their program between September 1, 2018 and August 31, 2019. Of the 91 students who started their program, 40 students completed their program of study within 150% of normal completion time. Please refer to the institution's catalog for the normal completion time of each program. The above data does not contain an exclusion of students whose last date of attendance was less than 30 days after the first class day of their program that was greater than one academic year in length and students whose last date of attendance was less than 15 days after the first class day of their program that was less than or equal to one academic year in length.

The combined **2018 Cohort Completion Rate** for first-time students in full-time programs at the campuses attached to the Office of Post-Secondary Education Identification (OPEID) number 021907 is **46%**. The OPEID number is comprised of Fortis College – Centerville, Fortis College – Cutler Bay, and Fortis College – Indianapolis. This rate is based on the 349 students who started their program between September 1, 2018 and August 31, 2019. Of the 349 students who started their program, 161 students completed their program of study within 150% of normal completion time. Please refer to the institution's catalog for the normal time of completion for each program. The above data excludes 8 students whose last date of attendance was less than 30 days after the first class day of their program that was greater than one academic year in length and students whose last date of attendance was less than 15 days after the first class day of their program that was less than or equal to one academic year in length.

- 1) The completion rates displayed above are based on first-time full-time students. As a result, these rates may not be representative of the entire student population.
- 2) The completion rates listed above are based on first-time full-time students. As a result, these rates are not representative of the entire student population.
- 3) A first-time student is defined as a student who has not previously attended a post-secondary institution. Students who did not identify their first-time status were assumed first-time students per guidance provided by IPEDS. As a result, it is possible the data above may also include non-first time students.
- 4) Full-time programs were determined using the full-time definition as defined by the Financial Aid Office.
- 5) We have elected not to report transfer-out rates because our school's mission does not include providing substantial preparation for students to enroll in another eligible institution without completing or graduating from our programs.
- 6) The required disclosure date for Completion Rates: The 2018 cohort is required to be disclosed by 7/1/22.
